

## The Southern Afghan Club List of Judges - A3 - 2007

	Indicates those persons whom the Club would support to award C.C.s in the Breed, having fulfilled the following criteria										
	a) Twelve years experience in the Breed. (Waived in the case of all rounders)										
	b) To have judged seventy-five classes at open show level spanning a minimum period of seven years										
	c) To have judged both sexes separately at an Afghan Breed Club show or a Breed Club sponsored show										
	d) To have judged a minimum of 150 Afghan Hounds										
	e) To have bred or owned a minimum of three dogs when they obtained their 1st entry into the KC Stud Book (save in exceptional circumstances) plus an additional fifty classes of Afghans (This to include a further ten class Breed Club show).										
	f) One of the two Club Shows must be balloted										
	g) To have stewarded not less than twelve classes of Afghans										
	h) To have passed a recognised Breed Club examination										
	i) To have attended a seminar given by a Kennel Club Accredited Trainer, and passed the relevant examination on Kennel Club Regulations and Judging Procedures.										
	j) To have attended a Conformation & Movement "Hands-On Assessment" conducted by a Kennel Club Accredited Trainer & to have passed the assessment.										
	k) To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement										
	l) To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club Code of Best Practice and passed an examination and/or assessment where applicable										
	m) ALLROUNDERS - To have awarded CCs in three hound breeds and to have judged a minimum of 150 classes of Afghans at open show level over a minimum period of 5 years.
